**Electronic Advance Directive Storage Systems** 

Dear Mr. Goldstone:

I am responding to your letter asking about the application of Joint Commission standards to an accredited hospital which you suggest would have ... "in place a system which adequately and effectively makes available stored advance directives to hospital personnel..," if that system relies on an electronic advance directive record storage system.

As we have discussed, Joint Commission standards require that advance directives obtained by an accredited hospital be readily available to hospital personnel when needed. Furthermore, the records need to be secure. There is nothing in the standards that prohibits a hospital from using an electronic advance directive record storage system to meet these requirements. The electronic system would have to be a tool in accomplishing this overall standards compliance.

Our surveyors at a hospital could well ask a number of questions to ascertain any organization's approach to advance directives. With regard to an organization utilizing an electronic system, they might ask, among other questions, about backup protection during any electronic down time, the availability of computer terminals for access, and the number of individuals and the time coverage of those individuals who would have access to the electronic database.
